

Law and Justice in Arkansas

The eighty-fourth Arkansas Historical Association (AHA) annual conference will be held at Fort Smith, April 10-12. Fort Smith was established as a U.S. military outpost in late 1817, to keep peace between the Osage and Cherokee nations. The city that developed around the fort became a hub for migrants heading west, as well as a seat of law and justice and headquarters for U.S. Marshals operating against outlaws. The U.S. Army continued to use the greater Fort Smith area as a military base (Fort Chaffee) from WWII to Vietnam, processed Vietnamese and Cuban refugees, and provided shelter to victims of Hurricane Katrina.

Conference sessions and luncheons will be held in the Fort Smith Bakery District at 70 S. 7th Street. Established as the Shipley Baking Company in 1921, the Bakery District is within walking distance of the conference hotel and the convention center.

Before attendees convene for the opening reception at the Fort Smith National Historic Site on Thursday evening, genealogist and historian Angela Walton-Raji will present a workshop entitled, "Bringing Peace to the Frontier: Lost Genealogy of Western Arkansas," in the Fort Smith Public Library Community Room.


On Friday afternoon, attendees can choose from two historic tours. Tom Wing will lead a bus tour of important Crawford County sites including the Drennen-Scott House and the Parley Pratt gravesite. Steve Kite, Tim Nutt and Erin Langford will lead a tour of two Fort Smith churches – Immaculate Conception Catholic Church and First Lutheran – and historic Oak Cemetery, the city's oldest and largest cemetery and the burial site of many prominent citizens.

Conference attendees will also have an opportunity to view, "We the People": Constitutions of the State of Arkansas, a traveling exhibit from the Arkansas State Archives. The exhibit will be on display in the Bakery District lobby throughout the conference.


